Subject: Monthly Activity Report – March 1, 2021 to March 31, 2021

Operations:

Emergency Incident Response:

On March 1, 2021 Engine 781 and Engine 4466 responded to a reported vehicle fire at 10918 Yosemite Springs Road. Upon arrival, there was a single passenger vehicle fully involved with fire threatening a structure. Fire crews immediately took suppression action containing it, preventing any extension into the structure or wildland. The cause of the fire is currently under investigation.

On March 27, 2021 CAL FIRE and Groveland Fire units responded to a reported escaped debris fire in the area of Short Line Road and Hells Hollow. Upon arriving at scene, there was 10 acres of brush and bug killed timber litter burning at a moderate rate of spread uphill. One structure was immediately threatened, and fire crews protected the structure and aggressively attacked the fire. Additional CAL FIRE and Tuolumne County Fire resources were ordered to protect the structures on Smith Station Road. Fire Crews worked vigorously worked through the night containing the fire at 22 acres. The cause of the fire is currently under investigation.
