A RESOLUTION OF THE GROVELAND COMMUNITY SERVICES DISTRICT BOARD OF DIRECTORS

CONFIRMING THE ASSESSMENTS AND AUTHORIZING THE PLACEMENT OF THE ASSESSMENTS ON THE PROPERTY TAX ROLLS FOR THE FISCAL YEAR 2002 - 2003.

WHEREAS, this Board did, pursuant to proceedings duly had, on the 8th day of July 2002, adopt its Resolution No. 10-02, ordering the formation of an Assessment District and Confirming the Diagram and Assessment, and the Engineer's Report prepared therefor, for annual installments for ten fiscal years commencing with fiscal year 2002-2003, pursuant to the provisions of Government Code Section 50078 et.seq and Article XIIIIC and XIIIID of the California Constitution

WHEREAS, the public interest and necessity require this Board to confirm and order the imposition of the annual assessment for fiscal year 2002-2003;

NOW, THEREFORE, BE IT RESOLVED, by the Groveland Community Services District Board of Directors as follows:

Section 1. That the annual total assessment for fiscal year 2002-2003 is \$198,072.00 which is equal to or less than, as described in Exhibit "A, Final Engineer's Report" attached hereto and by reference incorporated herein, and it is hereby, confirmed as the assessment for said fiscal year pursuant to said Engineer's Report, said provisions of the Government Code Section 50078 et.seq and Article XIIIIC and XIIIID of the California Constitution and said Resolution No. 10-02.

Section Two. That the Tuolumne County Auditor and the Tuolumne County Tax Collector apply the Big Oak Flat - Groveland Fire and Rescue Assessment District annual assessment for fiscal year 2002-2003 to the tax roll and have the Tuolumne County Tax Collector collect said assessment in the manner and form as with all other such assessments collected by the Tuolumne County Tax Collector.
